

Contest Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

Purchase does not increase chance of winning.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (each eligible person to enter is an (“Entrant”)) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Contest.
2. **Name of Contest:** 2024 Schedule Challenge Contest (the “Contest”)
Contest Period: Begins 12:01 AM EDT on April 11, 2024 and ends 11:59 PM EDT on April 30, 2024 (the “Contest Period”). Despite the April 30, 2024 deadline, the NFL schedule will not be finalized until early to mid-May.
Selection Date: Within approximately five (5) business days after the 2024 NFL schedule has been released to the public.
Prize Description: One (1) helmet autographed by a Bills player and two (2) tickets to a Buffalo Bills home game during the 2024-2025 NFL Season.
3. **Quantity and Value of Prizes to be Given Away:** One (1) winner. Total approximate total retail value of prize is \$500.00 USD.
Sponsor(s): Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the “Bills”) and Ticketmaster, LLC, 325 N Maple Drive, Beverly Hills, CA 90210 (collectively, the “Sponsor”).
4. Open to legal residents of the United States residing in New York State eighteen (18) years or older at time of entry. Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.

When completing an entry via this digital entry method, entrants will be asked to provide their full name and email address (among other information and the Bills NFL 2024-2025 schedule release related questions), which entry process must be completed during the Contest Period stated in Paragraph 2 above. Limit one entry per person; during the Contest Period. Multiple entries will not increase chances of winning and may result in Entrant’s entry being filtered out. Enter using only a valid email account held by the Entrant. All entries must be received by the Contest Period deadline stated in Rule No. 2. In the event of a dispute about entries submitted by multiple individuals using the same email account, entry will be deemed to have been submitted by the authorized holder of the email account used to enter the Contest at the actual time of entry. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified. The Bills shall judge entries based on qualitative criteria, including without limitation how accurate the Entrant has identified the Bills 2024-2025 NFL schedule as described in the instructions. The Prize description and quantity of Prizes to be given away are stated in Rule No. 2. Prize consists of only those items specifically listed as part of the prize. All prizes stated in Rule No. 2 will be awarded, assuming sufficient entries. The selection of the winning entry and awarding of prize(s) will be conducted under the supervision of the Buffalo Bills whose decisions are final and binding in all matters pertaining to this Contest.
