

Contest Official Rules

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (Entrant's) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Contest.
2. **CONTEST DETAILS.**

Contest Period: Begins 12:01am on April 6, 2022 and ends 11:59am on April 20, 2022
Selection Date: On April 21, 2022
Prize Description: One (1) winner will win a trip to Las Vegas for them and one (1) guest to attend the 2022 NFL Draft Inner Circle on April 28 and 29th. The winner will also receive one (1) hotel room for three (3) nights (4/27-29) and roundtrip flights to Las Vegas for them and their guest. They will also receive a Caesars Prize Pack.
Quantity and Value of Prizes to be Given Away: One (1) winner; Approximate total retail value of the Prize is \$2,475
Sponsor: Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the "Bills"). Caesars Entertainment Inc is not a sponsor of, or responsible for conducting, the Contest.
3. **ELIBILITY.** Open to legal residents of New York State and Southern Ontario, Ontario, Canada who are 21 years or older at time of entry (each eligible person to enter is an "Entrant"). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.

All entries must be received by the Contest Period deadline stated in Rule No. 2. The eligible entrant with the most collective points awarded will win the Prize.
